

## Contractor Appendix Söderenergi AB Igelstaverket

### RESERVATION AND HANDLING OF SITE HUTS IGELSTAVERKET SÖDERENERGI AB.

*Generally:* Söderenergi have retained to Cramo AB to establish modules for contractors within the site of Igelstaverket, Nynäsvägen 43, Södertälje.

**Ordering Staff & Office Site huts.** [The hut is shared and host 60 persons.](#)

#### Contractors Responsibility

Contractor/Manager/Entrepreneur are responsible for **booking the use of shared site huts** according to the procedure bellow:

- **Site huts must be ordered no later than 4 weeks before start of revision.** *It is the respective contact person at Söderenergi who informs about which dates to apply.*
- **The booking is made through a form** where; day of arrival, need for number of accommodations per week, estimated end date and contact person, is applied.
- **Individual entrepreneur is assigned two lockers**, inform that padlocks must be supplied of their own and that the lockers must be emptied and unlocked by the end date of the booking period. *After that date the lockers that are locked are emptied and the contents thrown away.*
- **Inform of the importance** to apply with the instructions and approach at site and within the huts.

The Contractor is responsible for all unforeseen costs if not pre-booked the execution of ordered services.

- Padlocks to lockers are provided by the entrepreneur. After completing the assignment, the lockers are cleaned out and left unlocked. Lockers that are not unlocked after the booked period are opened and the contents are thrown away.
- Overnight stay is not allowed in the hut.
